31 August 2021

EYBA Public Statement concerning the Situation in Afghanistan

The EYBA expresses its solidarity with the people of Afghanistan and deep concern about reports of serious human rights violations and abuses across the country.

The EYBA stands beside the G7 bar associations and other international organisations in urging the international community to provide protection and safe passage for all the judges, lawyers, human rights defenders and court staff, particularly the women, who have worked to uphold the rule of law and protect fundamental freedoms, for the past years, and may now face risk of intimidation and persecution after the takeover by the Taliban.

EYBA STATEMENT ON THE HUMAN RIGHTS DAY 10th of December 2021

"To deny people their human rights is to challenge their very humanity" Nelson Mandela

The Universal Declaration of Human Rights was adopted on 10th December 1948 as "a common standard of achievement for all peoples and all nations".

Since then, 73 years have passed and we are still facing inequalities and several adjustments. Today these are highlighted because of the pandemic and it's socio-economic consequences, the gap between rights and the rule of law has grown bigger. States, all over the world, have been faced with difficult challenges, and have been tempted to diminish human rights protections.

Therefore, not surprisingly, on this year's Human Rights Day 2021 the theme is "Equality, Reducing inequalities, advancing human rights".

The European Young Bar Association stands with the Declarations held by the Council of Europe on this. In particular, with regards to the highlighted issue of women rights and the right to health.

It is estimated by the United Nations that for 3 women 1 has been offended - by any mean adopted in the Convention, such as physical violence, emotional violence, harassment. These figures are devasting and the rule of law should be enforced in a protective manner. We, as a society, should also stand together against any form of violence and denounce it in a way that victims are protected and safe.

When it comes to the right of health, it should be understood, as the right to access health. The pandemic has exposed how the health access is a rare gift only accessible to some countries. For example, vaccines are still a major issue in some African countries. If we do not supply all the countries with vaccines, how come can we expect to develop an equitable health system?

Finally to all endangered lawyers in Afghanistan – who are practicing without being granted the due independence and due safety. The European Young Bar Association stands next to them and support their struggles.

EYBA STATEMENT 24.01.2022 International Day of the Endangered Lawyer 2022

The 24th of January has been designated as the annual International Day of the Endangered Lawyer in memory of the "Massacre of Atocha" occurred on this day in 1977 when four lawyers and a coworker were murdered and four others were heavily injured at their address at Calle Atocha 55 in Madrid.

The twelfth annual **Day of the Endangered Lawyer**, on **January 24**, **2022**, will focus for the second time on **Colombia**, where the persecution of lawyers continues, preventing them from exercising their profession.

As sadly highlighted in the Report drafted by the Foundation "Day of the Endangered Lawyers", the International Observatory for Lawyers in Danger and Avocats Européens Démocrates, "more than 700 lawyers have been killed in the previous ten years and more than 4,400 have suffered different types of aggression (...) between January 2019 and April 2021, 6 homicides, 26 threats, 12 attacks, 3 victims of legal proceedings and one exile among judicial professionals. Lawyers and human rights defenders are particularly at risk when representing clients in cases related to environmental law, land restitution and the Special Court for Peace. (...) Colombia also continues to fail to properly investigate and prosecute threats against lawyers involved in sensitive cases. (...) Some colleagues, involved in sensitive cases, are also the target of smear campaigns, which makes them particularly vulnerable to threats and increases risks to their live⁶.

As the EYBA is founded on key fundamental principles such as democracy, human rights, access to justice and the rule of law, we share the Requests and Recommendations listed in the Report addressed to the Colombian State and we call again for attention to lawyers all over the world who continue to carry their profession in order to guarantee access to justice, right to a fair trial and effective judicial protection, despite the risk of being murdered, persecuted, threatened, despite the risk of being the target of smear campaigns and hate on social media.

REGARDING THE SITUATION IN UKRAINE

Registration of the EYBA in the EU Transparency Register

Registration date: 02/09/2021



The European Parliament, the Council of the European Union and the European Commission are open and transparent in their regular dialogue with interest representatives and civil society. The Transparency Register is a tool to allow European citizens to see what interests are being represented at Union level and on whose behalf, as well as the financial and human resources dedicated to these activities.

ADVANTAGES OF BEING REGISTERED:

Access for interest representatives to decisionmakers, premises and certain fora in the Parliament and the Commission are subject to registration, according to the internal rules and decisions of each institution.

A Participant Identification Code (PIC) is a 9-digit number that serves as a unique identifier for legal entities participating in European funding programmes.

A PIC number has no expiry date.

If, in the future, EYBA wants to participate in a EU call for proposals or in a EU call for tenders with eSubmission, it needs to be registered and have a PIC number.

EYBA applied on the 4th of March, obtaining a preliminary PIC number. We are waiting for the further steps of the validation process.

REPORT OF THE EYBA ACTIVITIES CONTRIBUTIONS TO EU LAW-MAKING

EUROPEAN YEAR OF YOUTH (2022) 14 December 2021

FEEDBACK BY THE EUROPEAN YOUNG BAR ASSOCIATION PUBLIC IDENTIFICATION NUMBER: 349030043996-35

The European Young Bar Association welcomes the announcement of the European Year of Youth 2022.

The Proposal for a Decision on a European Year of Youth 2022 is particularly important in this historical moment of repair and recovery. Covid has shaken Europe and has had a strong impact on education, employment and mental health, to the detriment of the youngest. We firmly believe that, especially in this period, fresh and broad-minded people are an indispensable resource. Therefore, young people (students and workers) should be supported, prioritised, inspired and actively involved, demonstrating that their conditions, their opinion and their contribution count.

For example, it is very important that "the active involvement and engagement of young people and youth civil society organisations in implementing the activities of the Year" is effective, through giving young people a specific and significant role in the meetings (mentioned by the Proposal) at national level but also at Union level.

We suggest the inclusion (at art. 4) of the appointment of a young national coordinator, together with the national coordinator, for organising the participation of Members States in the European Year of Youth.

We have a similar suggestion with regard to the Coordination at Union level (at art. 5), where it should be provided that the young national coordinator is allowed to participate to the meetings of the national coordinators in order to coordinate the running of the European Year.

With regard to art. 6, we suggest that in advance all the stakeholders and representatives of organisations or bodies in the field of youth are identified and informed, about the programme and a dialogue initiated with them, harnessing their expertise in the different areas in order to reach as many young people as possible (especially in the less privileged countries) to raise awareness on the opportunities created in the context of the Year of Youth, particularly those where funding is available. Widespread communication is fundamental for the success of the Year.

Moreover, it would be useful to launch a survey among the stakeholders and representatives of organisations or bodies in the field of youth to identify the major challenges for young people.

With regard to the EU funding, it is necessary that a dedicated budget is assigned to the European Year of Youth, leaving untouched the budget that is already assigned to the other programmes listed in the Explanatory Memorandum of the Proposal.

It is crucial that, beyond the Year 2022, long-term projects are implemented to ensure continuity and consistency.

At the European Young Bar Association, we are looking forward to working closely with the European Commission, the European Parliament and Member States, to co-implement the Year of Youth and guarantee a legacy for the young generations to come.

Adapting liability rules to the digital age and Artificial Intelligence

Fields marked with * are mandatory.

Introduction

This public consultation aims to:

- confirm the relevance of the issues identified by the 2018 evaluation of the Product Liability Directive (e.g. how to apply the Directive to products in the digital and circular economy), and gather information and views on how to improve the Directive (Section I);
- collect information on the need and possible ways to address issues related specifically to damage caused by Artificial Intelligence systems, which concerns both the Product Liability Directive and national civil liability rules (Section II).

Thanks to Agatha Bulha (member of the EYBA CoE committee) and Borja Llonin (member of the EYBA Research Committee), who both have experience in the field of Artificial Intelligence, the EYBA has given its contribution to the EU consultation named "Adapting liability rules to the digital age and Artificial Intelligence". An initiative that proposes to adapt the framework of the current rules on liability for damage caused by new and refurbished products to take account of developments linked to the move towards a circular and digital economy, also addressing challenges brought about by artificial intelligence.

Introduction

The ongoing digital transition of the economy and society has substantial impacts on companies, including small and medium-sized companies (SMEs). More recently, the COVID-19 pandemic showed clearly that digital tools are essential to ensure the continuity of business operations and interactions with authorities on company law related issues. Companies, in particular SMEs, should be able to have full recourse to digital tools when they are set up and throughout their operations across the single market. Authorities also need to adapt their working methods and ways of cooperation with each other, and with businesses and other stakeholders, and to fully use digital technologies. Thanks to Pier Paolo Picarelli (member of the EYBA Research Committee), the EYBA has given its contribution to the EU consultation named "Upgrading digital company law ". This EU company law initiative aims to:

- improve transparency on EU companies by making more information available on a cross-border basis
- enable the cross-border use of trustworthy company data
- further modernise EU company law rules to make them fit for the digital age.

The EYBA, through its representatives Robert McTernaghan and Michalis Mittas, has contributed to the press release of the Migration Committee on the situation at the Polish-Belarusian border.

The President of the Conference of INGOs has joined the Committee to denounce the situation and to call on other Council of Europe bodies.

Therefore, <u>the European Young Bar Association</u> <u>has created a list of lawyers expert in migration</u> <u>law, refugee law and human rights</u>, in the European countries, that are available to give advice for the Ukrainians who are currently outwith the country seeking protection.

Our list currently includes more than 150 lawyers from more than 20 countries.

The initiative received support from several organizations that shared our list and from the Conference of the INGOs of the Council of Europe.

The CCBE has included the EYBA list in the list of contact points indicated by bars and law societies providing legal assistance to people fleeing the war in Ukraine.

On the 17th of December, the European Young Bar Association (EYBA) signed a cooperation agreement with the Academy of European Law (ERA) to promote closer cooperation between them and to facilitate the participation of members of EYBA in ERA training events.

The Academy of European Law, created in 1992 in Trier, aims at enabling individuals and authorities involved in the application and implementation of European law to gain a wider knowledge of European law and its application and to make possible a mutual and comprehensive exchange of experiences.

Members of EYBA are granted, through a dedicated voucher code, a regular 25% discount on the participation fee for ERA events and e-learning products in which the regular ERA discount scheme applies.

Contribution to the EU/CoE regional project

The EYBA is contributing to the regional project "Strengthening the profession of lawyer in line with European standards" by supporting the youth in the legal profession in Armenia, Georgia, Moldova and Ukraine, funded by the European Union and the Council of Europe.

The Project aims at strengthening the cooperation between the Bar associations and law societies of the participating countries in order to improve their internal functioning and independence in accordance with the Council of Europe standards and recommendations.

One of the initial goals of the Project was to create a Regional Network between the young lawyers' associations of the target countries.

As the EYBA is a network of European young lawyers' associations, and already includes organization members from Moldova and Ukraine, the Council of Europe - together with the involved young lawyers' associations and the EYBA executive committee – have reached the agreement to create a committee integrated in existing EYBA network, open to young lawyers' associations from Eastern European non-EU jurisdictions.

As a result of the EYBA involvement, 4 new associations (2 from Georgia, 1 from Armenia, 1 from Ukraine) have become members of the EYBA and a special committee, with representatives of each targeted country, will be presented ath the AGM for approval.

The CoE is supporting the membership of the above associations and their partecipation to the EYBA Summer Conference & AGM.

Judicial training for young lawyers

Following the cooperation agreement between EYBA and ERA, ERA has requested EYBA to become partner in submitting a project in response to the European Commission's call for proposals on judicial training for young lawyers in the area of EU law.

- data protection law and privacy law
- rule of law including the related CJEU and ECtHR rulings.
- topics affecting the European legal profession

EYBA have participated as associate parnter to the submission of the application and, in the event of a successful outcome, EYBA is committed to:

- disseminate information/raise awareness among the members of EYBA on the entire project;
- advise ERA on the programme, appoint experts/speakers for the courses;
- contribute financially by securing some places reserved to EYBA members selected through a call for application.

Cross-border HELP Course "Ethics for Lawyers"

The EYBA in cooperation with the Council of Europe HELP Programme and the European Association of Lawyers (AEA-EAL) has implemented a free on-line HELP Course "Ethics for Lawyers" for a group of lawyers from EU and non-EU countries.

The HELP course covers in an interactive way the key concepts and principles, the International and European (CoE and EU) framework as well as the relevant case law of the European Court of Human Rights (ECtHR) and of the Court of Justice of the European Union (CJEU). It seeks to address ethical dilemmas in the performance of professional duties by deepening the knowledge and understanding of professional tools and developing reflective skills, based on practical examples.

Cooperation with the Coalition for the Endangered lawyers

On 10 March 2022, the EYBA was included in the Cooperation with the Coalition for the Endangered lawyers. The purpose of the Day of the Endangered Lawyer is a call for attention on that day to threatened human rights lawyers with special attention to one designated country. The course of action is to draw a centralized petition in as many cities as possible, in and across Europe's borders, which will be offered to ambassadors, consulates and other bodies of authority. The petition will call for attention to the problematic situation of endangered lawyers in that country. Another aim is to engage in a dialogue with the representatives.

Contribution for the future European Convention on the Profession of Lawyer.

On 19 January 2022, the EYBA sent a letter to the Committee of Ministers of the Council of Europe and the European Committee on Legal Cooperation with regard to the Contribution for the future European Convention on the Profession of Lawyer.

The Council of Europe is creating a working group of experts devoted to the elaboration of the future binding instrument addressing the profession of lawyer. Therefore, EYBA has expressed its interest in providing expertise and further contribution to the elaboration of the future instrument, which, we believe, should reflect the view of the young generation of practicing lawyers.

We asked the Committee of Ministers to consider appointing one representative of the EYBA as member or as observer of the Group of Experts that will work on the drafting of the future convention.

On 20 april 2022, we have been informed that the Bureau has been tasked by the CDCJ to prepare a set of criterion for the evaluation of requests for an observer status within the Committee and its subordinate bodies. The Bureau decided on the criteria to be proposed to the CDCJ, that will be examined and adopted at next plenary meeting of CDCJ in June. Only after that the Committee will review and assess the requests received in 2021.

Cooperation with the CCBE

On 15 December 2021, the EYBA sent a letter to the President of the Council of Bars and Law Societies of Europe (CCBE), James MacGuill, to congratulate for the appointment, to present the EYBA and invite him to the EYBA Spring Conference.

It followed two meetings, on 15 and 28 February 2022.

James MacGuill intervened at the Spring Conference in March 2022. The CCBE has mentioned the EYBA Spring Conference in its newsletter.

The CCBE migration committee has been in contact with EYBA with regard to the list of lawyers in support of Ukrainians. The CCBE has included the EYBA list in the list of contact points indicated by bars and law societies providing legal assistance to people fleeing the war in Ukraine.

Letter to the new President of the European Parliament

On 24 January 2022, the EYBA sent a letter to the President of the European Parliament, Roberta Metsola, to congratulate for the appointment, to present the EYBA and invite her to the EYBA Spring Conference. The President's assistant has answered thanking the EYBA and wishing us luck with the organisation of the Conference.

INVOLVEMENT OF EYBA MEMBERS

EXAMPLE CONFICT OF CO

On the 17th of February, the European Parliament voted on a resolution on Empowering European Youth in the context of the European Year of Youth and our society post-covid (2021/2952(RSP)).

In particular, the European Parliament condemns the practice of unpaid internships as a form of exploitation of young workers, and a violation of their rights, and calls on the European Commission and the Member States, to propose a common legal framework to ensure fair remuneration for traineeships and apprenticeships in order to avoid exploitative practices.

The EYBA launched a survey in order to:

- collect the national rules (laws or code of conducts) regarding legal traineeship (focused on the remuneration) specifying if those rules are mandatory or not, and if there is any remedy for a young legal trainee with respect to violation of the rules;
- evaluate if those rules are respected in practice (whether or not they are mandatory) or if there is still a phenomenon of "exploitative practices".

Members received the survey on 2 May 2022. We are collecting answers.

On the basis of the answers, the EYBA will prepare and publish a comprehensive analysis to raise the awareness and support the European goals.
